

The (Often Unwitting) Enemy Within

You've locked down your networks, patched your software and are as protected against external threats as possible. Congratulations, you've made a good first step, but it is only a first step. External threats pale in comparison to internal threats in terms of both how frequently businesses are harmed by them and the scale of the damage that they can cause. There are three types of internal threats. The first kind is the '...wolf in the clothing of John from accounting, or the criminal who socially engineers their way inside your organisation and goes about achieving their goals from within. The second is the disgruntled insider, who does much the same thing, but using access that you have willingly granted them for their job.

Finally, we have human error, or the employee who drops the ball and puts your whole organisation at risk. Perhaps they're a bit too eager to click on links in strange emails, or they think 'passw0rd' is a perfectly good choice for all of their logins (it has a zero in it, after all). One survey revealed that 84% of respondents who had experienced breaches '... attribute[d them], at least in part, to human error.' Similarly, a 2017 report found that 100% of US government workers viewed their own employees as the most likely culprits during a security breach—almost half of the time unintentionally so.

You'll have policies in place. You may even attempt to educate your employees on them. However, that's no longer enough—changing your business culture is key. You need each employee to consider security as second nature. You need your policies and your training to align smoothly. You need the operational functionality to view, at-a-glance, your business' levels of risk, resilience and compliance, and where any weaknesses lie. Mitigate enable all of this.
